Quaker Marsh property - .74 acres





- Conservation values include:
 - Estuarine habitat, coastal bank, freshwater wetland fringe and salt marsh
 - Scenic vistas of Wild Harbor River estuary and salt marsh
 - Linkage to Town-owned open space (and potential future open space acquisitions nearby)
- Additional public benefits:
 - Public access to Wild Harbor River
 - Visual impact along roadway











Restoration Goals





Create vegetated buffer along neighboring parcel boundary & wetland river bank Enhance habitat - remove invasive species - re-vegetate with herbaceous plants and low growing shrubs - install osprey pole Enhance public access & appreciation - Kayak launch - Benches

Total Cost: \$367,856


Acquisition -\$355,000
 Demolition - \$12,856 (includes re-grading)



Bartolomei Conservation Area

- Conservation values include:
 - Linkage to protected open space in the Coonamessett River corridor
 - Estimated rare species habitat
 - Water frontage, wetlands, herring run, and natural vegetation
- Additional public benefits:
 - Scenic views
 - Public access for canoeing and kayaking
 - ADA compliant handicapped accessibility



Bartolomei Undevelopment

Total Costs: \$1,050,097

- Acquisition -\$1,000,000
- Demolition \$18,245
- Grading and seeding \$4,020
- Fuel tank removal \$300
- 21 E assessment & remediation \$7,532
- Handicapped trail \$22,000

Partners:

- LAND Grant \$500,000

Allow plenty of time for all details to be taken care of:

- Possible asbestos removal or other environmental remediation
- Utilities (Dig Safe, water, electricity, septic, oil tanks)
- Demolition permitting (Building Dept., Con Com, DNR)
- Take care to work through conflicting issues
- Budget for "all angles" of the project:
 - Demolition costs (buildings, pavement, fencing, debris)
 - Environmental testing & remediation costs (21E assessment, asbestos)
 - Restoration costs (re-vegetation, trails)
